Isentia shareholders vote in favour of Scheme of Arrangement

Isentia Group Limited (ASX: ISD) (**Isentia**) is pleased to announce that Isentia shareholders today voted in favour of the scheme of arrangement under which Access Intelligence plc (a company incorporated in England and Wales with company registration number 04799195) will acquire all of the Isentia shares that it does not already own (**Scheme**).

Voting results of the Scheme Meeting

For the purposes of ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act* 2001 (Cth) (**Act**), Isentia advises that the resolution to approve the Scheme as set out in the notice of scheme meeting attached to Isentia's scheme booklet dated 19 July 2021 (**Scheme Resolution**) was passed by the requisite majorities of Isentia shareholders.

In summary:

- 81.45% of Isentia shareholders present and voting at the scheme meeting (via Isentia's online meeting platform or by proxy) being in favour of the Scheme Resolution; and
- 91.96% of the total number of votes cast on the Scheme Resolution at the scheme meeting (via Isentia's online meeting platform or by proxy) being in favour of the Scheme Resolution.

Full details of the poll and proxy results are set out in **Annexure A** to this announcement.

In commenting on the result, Isentia's Chairman, Doug Snedden said "The Board is delighted that shareholders overwhelming supported the proposal from Access Intelligence."

Next Steps

Isentia will seek orders from the Supreme Court of New South Wales (**Court**) for the approval of the Scheme at the second court hearing, scheduled for 9.15am (Sydney time) on Friday, 20 August 2021.

If the Court approves the Scheme, Isentia proposes to lodge the Court orders with the Australian Securities and Investments Commission on the same day so that the Scheme becomes legally effective in accordance with sub-section 411(10) of the Act on Friday, 20 August 2021.

Subject to the Scheme becoming effective on Friday, 20 August 2021:

• it is expected that Isentia shares will be suspended from trading with effect from the closing of trading on the ASX on Friday, 20 August 2021;



- the Scheme record date (for determining entitlements to the Scheme consideration)
 will be Wednesday, 25 August 2021; and
- the Scheme is expected to be implemented on Wednesday, 1 September 2021.
