**FLAGSHIP INVESTMENTS LIMITED (FSI.ASX) TO RAISE  
UP TO \$20 MILLION THROUGH A LISTED UNSECURED  
REDEEMABLE CONVERTIBLE NOTE ISSUE**

Flagship Investments Limited (FSI or the Company) has today lodged a prospectus (Prospectus) with the Australian Securities and Investments Commission (ASIC) for the issue of listed, redeemable, unsecured convertible notes (FSI Notes), (the Issue). A notice of meeting for the AGM will be sent to FSI Shareholders shortly which explains that the proposed issue of convertible notes falls outside FSI's current 15% placement capacity and therefore shareholder approval is required for the purpose of ASX Listing Rule 7.1

The FSI Notes will provide investors with a listed exposure to a fixed interest rate yield and the possibility to benefit from appreciation in the price of FSI ordinary shares (Ordinary Shares) above a Conversion Price of \$2.70 through an optional conversion into Ordinary Shares at any time from the second anniversary of the issue date of the Convertible Notes until 17 September 2026.

The Board of Directors of FSI believe that the issue of FSI Notes provides the ability to increase the overall size of the investment portfolio without diluting existing FSI Shareholders. The additional capital will be deployed in accordance with FSI's existing investment mandate and investment process.

The Board fully support the FSI Notes offer and, subject to Shareholder approval being obtained in respect of such, intend to participate on the following basis:

**Key terms of the FSI Notes**

- ◆ Total offer size of up to \$20.0 million
- ◆ Offer price of \$2.70
- ◆ Interest rate:
  - 5.50% paid quarterly until Step Up date of 30 September 2024
  - After Step up date (3 years after issue) increases to 6.50% if 2 year Bank Bill Swap rate is above 1.2832%
- ◆ 1 Convertible Note converts to 1 ordinary share
- ◆ Maturity date of 1 October 2026 (5 years) (if not converted or redeemed earlier)
- ◆ Priority Offer to existing shareholders of FSI or any other party as determined by FSI in its discretion and a Broker Firm Offer

The Issue comprises two components, a Priority Offer and a Broker Firm Offer

#### *Priority Offer*

An offer open to Eligible Participants, being any person who has a registered address in Australia and who as at the Priority Offer Record Date of 27 August 2021 was a shareholder of FSI or any other party as determined by FSI at its discretion.
