## **QANTM ACQUIRES SORTIFY.TM LIMITED**

# Increasing trade mark filings, driving digital strategy and entering new markets

QANTM Intellectual Property Limited (ASX: QIP) today announces that is has finalised arrangements to acquire Sortify.tm, a New Zealand based trade mark legal tech company.

- Deal amount AU\$11 million: Up-front consideration of AU\$8 million and deferred consideration of up to AU\$3 million payable in 2 annual instalments subject to performance requirements. \$1m of the up-front consideration, and up to \$1m of each deferred instalment, will be paid through the issue of QANTM shares
- Deal expected to complete on 30 September 2021

Sortify.tm was founded in New Zealand by Claire Foggo, Alan Potter and Narly Kalupahana. A trade mark legal tech company that grew out of a traditional trade mark practice, Sortify.tm provides technology solutions to brand owners and IP practitioners, as well as public and private sector entities.

In the 2021 financial year, Sortify.tm's trade mark filing platforms achieved the following:

Sortify.tm's platforms filed more Australian and New Zealand trade marks for local Australian and New Zealand businesses than any other IP services provider in FY21. QANTM and Sortify plan to pursue a number of additional international market opportunities together.

Sortify.tm also has built a suite of trade mark practitioner tools, incorporating artificial intelligence and automation, which are currently being used by trade mark attorney and law firms globally (including in Australia, New Zealand, USA, UK, Singapore and Canada) to assist with their trade mark practices. The acquisition of Sortify.tm is likely to be earnings accretive within 12 months and will bring value to QANTM's program of IT modernisation as well as expansion in the Asia-Pacific region, allowing the QANTM group to capture new and emerging market opportunities.

QANTM group companies will also provide related legal, patent and trade mark attorney services to Sortify.tm customers which are outside of Sortify.tm's current offering.
