Natshield™ Receives Trademark Approval For Sales in China

Holista Colltech Limited (ASX: HCT, "Holista" or "the Company") is pleased to announce that it has been successful in securing trademark labelling approval in China for its Natshield™ sanitiser brand. It is called "Na Xi Er De" in China.

The approval, which was granted by the China National Intellectual Property Administration (CNIPA), is for Trademark Class 5 – a category that relates mainly to pharmaceuticals and other preparations for medical or veterinary purposes.

The trademark is valid for 10 years and it provides brand name protection as Holista prepares to launch its NatshieldTM aerosol disinfectant and M3 System for industrial applications in the Chinese market. No further approvals are needed for commercialisation purposes.

Further, Holista's Chinese business partner Guangzhou Sinbio Cosmetic Co Ltd will soon commence the process of applying for medical use standards for products to be sold into hospital.

This announcement has been approved by the Board of Directors.
