Mr Thomas Bogan was to pay A\$999,067.50 as consideration for the 525,825 placement Shares to be issued to him pursuant to a Directors' placement announced on ASX on 23 June 2021. The Company determined that it was beneficial for it to receive USD instead of AUD as consideration for these placement Shares. Mr Bogan agreed with this approach. A spot USD/AUD exchange rate of 1.366858 from 17 September 2021 was used to calculate the equivalent US\$730,922.67 consideration, which was paid.
