

## Elsight Appoints Jim Landau to Board of Directors

Jim is based in Melbourne, Australia and holds Fellowships of the Australian Society of Certified Practicing Accountants, the Financial Services Institute of Australasia, and the Australian Institute of Company Directors. Jim has an Honours Degree in Electrical Engineering from Monash University.
