**Seafarms Group Limited – Request for Voluntary Suspension**

Further to Seafarms Group Limited's (**Seafarms** or the **Company**) request for a trading halt on Thursday, 7 October 2021 and in accordance with ASX Listing Rule 17.2, Seafarms requests a voluntary suspension from the commencement of trading on Monday, 11 October 2021 (immediately after the cessation of the trading halt) pending an announcement to the market regarding material information in respect of project costs.

The voluntary suspension is required as the Company has been unable to finalise a market update, review and authorise it, and then release before the open of the market at 10am Eastern time on Monday, 11 October 2021.


The Company anticipates the voluntary suspension will be lifted on or before market open on Tuesday, 12 October 2021 by provision of an announcement to the ASX.
