

Notice Under Section 708A(5) of the Corporations Act 2001

This notice is given by Titan Minerals Limited (ASX: TTM) (**Titan** or the **Company**) in relation to the issue of 203,000,000 fully paid ordinary shares (Shares) as detailed in the Appendix 2A's announced on 13 October 2021.
