All your securities will be voted in accordance with your directions.

APPOINTMENT OF PROXY

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. 

ENTITLEMENT TO VOTE

Pursuant to regulation 7.11.37 of the *Corporations Regulations 2001* (Cth) and ASX Settlement Operating Rule 5.6.1, the Company has determined that for the purposes of the Meeting, all ordinary shares in the Company shall be taken to be held by the persons who are registered as shareholders of the Company as at 7.00pm (Sydney time) on Sunday, 21 November 2021 ("**Entitlement Time**").

Ordinary Business:

Financial Statements and Reports

The *Corporations Act 2001* (Cth) ("**Corporations Act**") requires that the Directors' Report, the Auditor's Report and the Financial Statements of the Company for the financial year ended 30 June 2021 be laid before the Meeting. In addition, the Company's Constitution provides for these Reports and Financial Statements to be received and considered at the Meeting. Resolution 1 – Re-election of Director (Ms Sandra C Birkenleigh)

Ms Birkenleigh was appointed to the Board on 2 February 2015 and was appointed the Chairperson of the Board on 1 January 2021. Ms Birkenleigh was previously a partner at PricewaterhouseCoopers for 16 years until 2013. During her career her predominant industry focus has been Financial Services (Banking and Wealth Management). Ms Birkenleigh has also advised on risk management in other sectors such as retail and consumer goods, retail and wholesale electricity companies, resources and the education sector. Ms Birkenleigh is currently a non-executive Director of MLC Insurance Limited, the National Disability Insurance Agency, Horizon Oil Limited, 7-11 Holdings and its subsidiaries and Your Best Life Disability and Health Services. She is an independent member of the Audit Committee of the Reserve Bank of Australia, and a Council Member of the University of the Sunshine Coast.

Ms Birkenleigh serves as Chairperson of the Board, is a member of the Board Audit Committee and attends the Board Risk Committee by invitation.

The Board considers that Ms Birkenleigh, if re-elected, will qualify as an independent Director of the Company.

The Board of the Company (with Ms Birkenleigh abstaining) recommends that shareholders vote in favour of Resolution 1.

Resolution 2 – Election of Director (Mr Grant B Murdoch)

Mr Murdoch was appointed to the Board on 1 January 2021. Mr Murdoch is a Chartered Accountant with over 37 years of experience and has previously served as a partner with both Ernst & Young and Deloitte. Mr Murdoch has extensive experience in providing advice on M&A, corporate restructures, share issues, pre-acquisition due diligence and expert reports for capital raisings and initial public offerings. Mr Murdoch is currently a non-executive Director of OFX Ltd, Lynas Rare Earths Ltd and UQ Holdings Pty Ltd, and serves as a Senator of the University of Queensland where he is also an Adjunct Professor at the School of Business, Economics and Law. Mr Murdoch was appointed as a non-executive Director of the following companies from 1 April 2021: Kiwicare Holdings Ltd, Kiwicare Corporation Ltd, Amalgamated Hardware Merchants Ltd, Burnetts Horticulture Ltd, McGregors Horticulture Ltd, and Amalgamated Hardware Merchants (Australia) Pty Ltd.

Mr Murdoch is chairperson of the Board Audit Committee, a member of the Board Remuneration Committee, the Board Risk Committee and the Board Credit Committee.

The Board considers that Mr Murdoch, if elected, will qualify as an independent Director of the Company.

The Board of the Company (with Mr Murdoch abstaining) recommends that shareholders vote in favour of Resolution 2.

Resolution 3 – Election of Director (Ms Jacqueline Korhonen)

Ms Korhonen has over 30 years' experience in the Information Technology, Telecommunications and Financial Services sectors, where she built her career around technology transformations, P&L management, complex negotiations, project delivery, operations, strategy development and risk management.

She started her career as an engineer in IBM where she spent 23 years living and working across Australia, New Zealand, ASEAN, India and China. After leaving IBM, Ms Korhonen was appointed CEO of Infosys Australia and New Zealand, a position she held for six years. In the later years of her Executive career Ms Korhonen was the CEO of SMS Management & Technologies, an ASX listed IT Services company and subsequently returned to IBM as the Vice President of Cognitive Transformation Services across the Asia Pacific Region.

Ms Korhonen was a non-executive director of NetComm Wireless until 2019. She is currently a non-executive director of MLC Insurance, Nuix and .au Domain Administration. In addition, Ms Korhonen is a member of the Board of Chief Executive Women.

Ms Korhonen is a member of the Board Remuneration Committee, the Board Audit Committee and the Board Risk Committee.

The Board considers that Ms Korhonen, if elected, will qualify as an independent Director of the Company.

The Board of the Company (with Ms Korhonen abstaining) recommends that shareholders vote in favour of Resolution 3.

Resolution 4 – Remuneration Report

Shareholders are asked to adopt the Remuneration Report. The Remuneration Report is set out on pages 33 to 43 of the Company's 2021 Annual Report. The Chairperson of the Meeting will give shareholders a reasonable opportunity to ask questions about, and comment on, the Remuneration Report at the Meeting.

The vote on this resolution is advisory only and does not bind the Directors of the Company or the Company. The Directors will consider the outcome of the vote and comments made by shareholders on the Remuneration Report when reviewing the Company's remuneration policies.

While the resolution is not binding on the Company, under the Corporations Act, if the resolution on the Company's remuneration report receives votes against of 25% or more at two consecutive Annual General Meetings, a resolution must then be put to shareholders at the second Annual General Meeting as to whether another meeting should be held within 90 days at which all Directors of the Company (other than a Managing Director) who were in office at the date of approval of the applicable Directors' report must stand for re-election.

Voting Exclusion Statement:

In accordance with section 250R(4) of the Corporations Act, a vote on Resolution 4 must not be cast (in any capacity) by or on behalf of either a member of the KMP of the Company (which includes the Directors of the Company) whose remuneration details are included in the Remuneration Report, or a closely related party (such as close family members and any entities the KMP controls) of such a person, unless:

- (a) it is cast by the person who is appointed in writing as a proxy for a shareholder who is entitled to vote, and the proxy form specifies the way the proxy is to vote on the resolution; or
- (b) it is cast by the Chairperson of the Meeting as proxy for a shareholder who is entitled to vote, and the proxy form does not specify the way the proxy is to vote on the resolution and expressly authorises the Chairperson of the Meeting to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP of the Company.

If the Chairperson of the Meeting is your proxy, and you fail to provide a voting direction in respect of Resolution 4 on the proxy form (which you may do by marking the 'For', 'Against' or 'Abstain' box opposite Resolution 4 on the proxy form), you are expressly authorising the Chairperson of the Meeting to vote in favour of Resolution 4 even if that resolution is connected directly or indirectly with the remuneration of Directors or members of the KMP of the Company. Subject to any applicable laws or voting exclusions, the Chairperson of the Meeting intends to vote all available proxies in favour of the resolutions in this Notice of Meeting (including Resolution 4).

Noting that each Director has a personal interest in their own remuneration from the Company, as described in the Remuneration Report, the Board of the Company recommends that shareholders vote in favour of Resolution 4.

Resolution 5 – Approval of Non-Executive Director Fees

According to ASX Listing Rule 10.17, the Company cannot increase the total aggregate amount of the non-executive Directors' fees payable to all of its non-executive Directors without shareholder approval. Resolution 5 seeks shareholder approval for the

purposes of ASX Listing Rule 10.17 and rule 14.1(b) of the Company's Constitution and for all other purposes, for the Company to increase the maximum aggregate amount of fees payable to its non-executive Directors by \$500,000, from \$500,000 to \$1,000,000 per annum. If approved, the increase will take effect for the financial year commencing 1 July 2021.

The Board considers that it is reasonable and appropriate at this time to seek an increase in the remuneration pool for non-executive Directors. The maximum aggregate fees payable to non-executive Directors of the Company has not been increased since 15 November 2012.

If Resolution 5 is passed the maximum aggregate amount of Directors' fees that may be paid to all of the Company's non-executive Directors will be \$1,000,000 per annum. This does not mean that the Company must utilise the entire maximum amount approved for non-executive Directors' fees in each year. However, the Board considers that the proposed increase is reasonable and appropriate to provide the Company with:

- the ability to pay non-executive Directors remuneration at levels commensurate with market rates and as necessary to attract and retain Directors of the highest calibre and with the requisite skills and experience as appropriate to oversee the Company's business and strategic direction; and
- the flexibility to increase the size of the Board, as considered appropriate, including in the near-term and for succession planning purposes.

If Resolution 5 is not passed, the Company will not be permitted to pay fees to its non-executive Directors which exceed the aggregate amount of Directors' fees already approved by shareholders as set out in this Notice of Meeting.

The remuneration of each non-executive Director for the year ended 2021 is detailed in the Remuneration Report in the Company's 2021 Annual Report in pages 33-43. No securities have been issued to the Company's non-executive Directors with shareholder approval under Listing Rules 10.11 or 10.14 within the preceding 3 years the date of this Notice of Meeting.

Voting Exclusion Statement:

The Company will disregard any votes cast in favour of Resolution 5 by or on behalf of:

- (a) a Director of the Company; or
- (b) an associate of a Director.

However, this does not apply to a vote cast in favour of Resolution 5 if:

- (a) it is cast by a person as proxy or attorney for a person who is entitled to vote, in accordance with the directions on the proxy form;
- (b) it is cast by the Chairperson at the Meeting as proxy or attorney for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the Chairperson decides; or
- (c) it is cast by a person acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - (i) the beneficiary provides written confirmation to the person that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on the resolution; and
 - (ii) the person votes on the resolution in accordance with the directions given by the beneficiary to the person to vote in that way.

The Company is also required under the Corporations Act to disregard any votes cast by a person in their capacity as a proxy on Resolution 5 by a member of KMP or a closely related party of that person, where the appointment does not specify the way the proxy is to vote on the resolution.

If the Chairperson of the Meeting is your proxy, and you fail to provide a voting direction in respect of Resolution 5 on the proxy form (which you may do by marking the 'For', 'Against' or 'Abstain' box opposite Resolution 5 on the proxy form), you are expressly authorising the Chairperson of the Meeting to vote in favour of Resolution 5 even if that resolution is connected directly or indirectly with the remuneration of Directors or members of the KMP of the Company. Subject to any applicable laws or voting exclusions, the Chairperson of the Meeting intends to vote all available proxies in favour of the resolutions in this Notice of Meeting (including Resolution 5).

Noting that each Director has a personal interest in their own remuneration from the Company, the Board of the Company recommends that shareholders vote in favour of Resolution 5.
