#### Request for suspension of securities from official quotation

Pursuant to ASX Listing Rule 17.2, Japara Healthcare Limited (ACN 168 631 052) (Japara) (ASX:JHC) requests the suspension from official quotation of Japara shares, effective from the close of trading today (being 25 October 2021).

This follows lodgement with the Australian Securities and Investments Commission (ASIC) of the orders of the Federal Court of Australia (**Orders**) approving the scheme of arrangement under which Little Company of Mary Health Care Limited will acquire all of the issued shares in Japara (**Scheme**). As a result, the Orders are now effective.

Japara provides the following information in accordance with Listing Rule 17.2:

- Japara requests the suspension from official quotation of Japara shares following lodgement with
  ASIC of the Orders approving the Scheme, to facilitate implementation of the Scheme.
  - Japara requests the suspension from official quotation of its shares until Japara requests to be removed from the official list of the ASX, which is subject to the implementation of the Scheme. Please do not remove Japara from the official list prior to receipt of the request to do so from Japara.
- 3 The request for removal from the official list is expected to be made following implementation of the Scheme, which is expected to occur on 5 November 2021.

- 4 Japara is not aware of any reason why Japara shares should not be suspended.
- 5 Japara is not aware of any other information necessary to inform the market about the suspension or that has been requested by but not yet provided to the ASX.
