



Letter to Shareholders Upcoming Annual General Meeting

Twenty Seven Co. Limited (ASX: TSC) (“**TSC**” or “**the Company**”) will hold an Annual General Meeting of its Shareholders (“**Shareholders**”) at 45 Ventnor Avenue, West Perth 6005, Western Australia at 2.00pm (WST) on Friday 26 November 2021 (“**the Meeting**”).

The Company will adhere to all social distancing measures prescribed by the Government authorities’ current restrictions for physical gatherings. If COVID-19 social distancing restrictions change prior to the Meeting, the Company will update Shareholders via an ASX announcement and the Company’s website.

In accordance with ASIC Corporations (Extension of Time to Hold AGM) Instrument 2021/770 (dated 7 September 2021) and temporary relief measures approved by the federal government in Treasury Laws Amendment (2021 Measures No.1) Act 2021 (Cth), the Company will not be dispatching physical copies of the Notice of Meeting (“**Notice**”) to Shareholders. Proxy votes may be lodged in accordance with the instructions set out in the Proxy Form. Proxy Forms must be received by 2pm (WST) on Wednesday, 24 November 2021. Any proxy voting instructions received after that time will not be valid for the Meeting.

The Notice and the accompanying Explanatory Memorandum should be read in its entirety. If a shareholder is in doubt as to how to vote, that shareholder should seek advice from an accountant, solicitor or other professional adviser prior to voting.

The Company appreciates the understanding of its Shareholders as it navigates this difficult situation.
