# Quarterly Activities & Cash Flow Report Quarter ended 30 September 2021

**Sydney, Australia – 29 October 2021:** OncoSil Medical Ltd (ASX: OSL) (**OncoSil** or the **Company**), has released its Appendix 4C – Quarterly Cashflow report for the quarter ended 30 September 2021 (the Quarter). OncoSil is a medical device company that is commercialising its platform technology for the treatment of patients with locally advanced pancreatic cancer (LAPC) and bile duct cancer or distal cholangiocarcinoma (DCC).

# **Key Highlights**

- PanCo clinical study: Finalised and closed out following delays due to COVID. Submitted for publication:
- USA HDE data package re-submitted to the FDA: Following the close out of the PanCo clinical study;
- European Union and the United Kingdom: With CE approval, breakthrough designation and reopening after COVID, the Commercial Team are active in assisting targeted sites with local regulatory and Osprey ethics approvals;
- APAC regulatory and commercial discussions continuing: Advancing discussions with APAC hospitals to obtain Osprey registry approvals; and
- Cash position: Cash balance of \$9.56 million as at 30 September 2021.

All financial results are in Australian dollars and are unaudited.

#### USA HDE data package re-submitted to the FDA

On 28 July 2020, OncoSil announced that it had filed a Humanitarian Device Exemption (HDE) application with the US Food and Drug Administration (FDA) for its OncoSil<sup>TM</sup> device in the treatment of distal cholangiocarcinoma (DCC or bile duct cancer).

The FDA requested an updated dataset involving more recent safety and efficacy data from the PanCO trial. Covid had impacted the ability for the Company to officially close out study sites and this negatively impacted the timing on finalising this data package. The data package involved the submission of hundreds of supporting documents consisting of updated data and reports. We have recently submitted the updated data with the FDA and are currently awaiting their review.



### **European Union and the United Kingdom**

Although COVID-19 has adversely impacted our ability in achieving first revenues in the European Union and the United Kingdom, our team has actively re-engaged with targeted sites, since face-to-face meetings have been allowed. Activities continue to concentrate on assisting with local regulatory approvals and ethics approvals for the OSPREY patient registry.

The Company has agreements in place with various distributors in EMEA serving countries which recognise the CE Marking approval for local distribution, as well as targeting smaller European countries where it is not economically viable to have direct staff employed in these regions. The initial targeted countries include Switzerland, Austria, Portugal, Greece, Israel, Turkey, and Egypt.

OncoSil will continue discussions with other distributors for countries in both EMEA and APAC to accelerate registration approvals of the OncoSil device in order to capitalise on market opportunities.

The Company has continued to work on several initiatives in preparation for market access, health insurance coverage and reimbursement applications in various European countries.

Although COVID-19 continues to disrupt operations in the UK, Europe and Middle East, OncoSil continues to advance its commercialisation plans and expects that a post-COVID return to normality will see increased site activation and commercial throughput which the Company is ready to capitalise on.

## **APAC: Regulatory and commercial discussions continuing**

OncoSil continues to engage with hospitals in the APAC region where the OncoSil<sup>TM</sup> device is approved. OncoSil continues to be in discussions with hospitals in Singapore, Hong Kong and New Zealand to obtain Osprey registry approvals that should lead to patient treatments and revenue growth. In Australia we continue to use the Special Access Scheme which enables Australian physicians to treat patients with our device provided OncoSil does not engage in promotional activity.

### **Board renewal**

In July 2021 Mr. Otto Buttula was appointed to the Board, being elected Non-Executive Chairman by the Board effective 20 October 2021. As part of the board renewal, Dr Chris Roberts, Mr. Mike Bassett, and Dr Roger Aston have stepped down from the Board.

Prof Ricky Sharma will be joining the OncoSil Medical board as a non-executive director on 1<sup>st</sup> November 2021. Prof Sharma is an international authority on the translation of radiobiology from the laboratory to the clinic and on the treatment of cancer with precision radiotherapy. Prof Sharma is an honorary consultant in clinical oncology at University College London Hospitals where he maintains a clinical practice in radiotherapy and chemotherapy.



#### Corporate

As at 30 September 2021, OncoSil had a cash balance of \$9.56 million. During the Quarter, the Company's net cash used in operations was \$2.7 million, with \$0.8 million invested in R&D activities. The Company also received \$1.08m from the Australian Government's R&D Tax Incentive program. Item 6.1 of the Appendix 4C relates to director fees and salaries paid in the quarter.

#### **About OncoSil**

OncoSil Medical is a medical device company seeking to advance radiation for cancer patients. OncoSil Medical's lead product, OncoSil™ is a targeted radioactive isotope (Phosphorus-32), implanted directly into a patient's pancreatic tumours via an endoscopic ultrasound.

Treatment with the OncoSil™ is intended to deliver more concentrated and localised beta radiation compared to external beam radiation. OncoSil Medical has conducted six clinical studies with positive results on tolerability, safety and efficacy. CE Marking has been granted for the OncoSil™ device which can be marketed in the European Union and the United Kingdom. The OncoSil™ device has also been classified a Breakthrough Device in the European Union and the United Kingdom.

An Investigational Device Exemption (IDE) has been granted by the United States Food and Drug Administration (FDA) to conduct a clinical study of the OncoSil<sup>™</sup> device aimed at supporting a PMA approval.

In December 2018, the FDA granted Humanitarian Use Designation (HUD) for the OncoSil™ device for the treatment of unresectable bile duct cancer. In March 2020, the FDA granted Breakthrough Device Designation for the OncoSil™ for unresectable pancreatic cancer in conjunction with systemic chemotherapy.

Pancreatic cancer is typically diagnosed at a later stage, when there is a poor prognosis for long-term survival. The World Cancer Research Fund estimated that in 2012, 338,000 people globally were diagnosed with pancreatic cancer. The prognosis for patients diagnosed with pancreatic cancer, regardless of stage, is generally poor; the relative five-year survival rate for all stages combined is approximately 5%. The estimated world-wide market opportunity for OncoSil™ in pancreatic cancer exceeds \$3b.
