Annual General Meeting Update

The Company further advises that a typographical error appeared in the wording of Resolution 4 on page 3 of the Company's notice of annual general meeting, as released to ASX and despatched to shareholders on 13 October 2021. The resolution incorrectly stated the expiry date of Performance Rights to Managing Director, Mr David Southam, as 30 June 2024.

As a result, the Board has resolved to withdraw Resolutions 4 and 5 (which was contingent on Resolution 4) from the annual general meeting and will put these resolutions to shareholders at a subsequent general meeting with the correct expiry date.

The Board will present the following information on instructions given to validly appointed proxies for Resolutions 4 and 5 at the annual general meeting but these resolutions will not be put to shareholders.
