

## Agreement with St John of God Health Care - update

**1st Group Limited (ASX: 1ST)**, the Australian digital health group, provides the following additional information in relation to its earlier announcement “*1st Group signs deal with St John of God Health Care*”, in response to an ASX request for a additional information.

*Whether the contract is effective immediately:*

The contract is effective immediately and work commences Monday 15 November 2021.

*Term of the contract:*

Each St John of God Health Care (SJOG) specialist signs up for an initial 12 month agreement with 1st Group.

*More specific information regarding the significance of the contract to 1ST, including the contracted dollar value of revenue, or whether the revenue under the contract is or is expected to be material for 1ST:*

SJOG is a significant national private hospital group.

Our contract with them follows our agreements with St Vincent’s Health and Cabrini Health.

Phase 1 of the agreement introduces our service to 440 specialists across two of their 17 hospitals. SJOG will initially contribute to the fees that are payable by each subscribing specialist to 1st Group’s service.

The value of the agreement is subject to the number of specialists who take up the service across the initial two hospitals. For example, if only 110 specialists sign up, the first 12 months of revenue would be around \$165k. If all 440 specialists sign up, initial annual revenue would be \$660k. If deployed to all 17 hospitals, this would be in the range of \$1.4m to \$5.6m.

*The key termination provisions in the contract (i.e. other material information relevant to assessing the impact of the contract on the price or value of the entity’s securities):*

SJOG can terminate the agreement with 30 days’ notice. Each specialist that takes up the service is signed up to an initial 12 month agreement. 1st Group cannot terminate the agreement for 18 months.
