MINERAL RESOURCE ESTIMATE (MRE) UPDATE

Due to global logistics constraints the completion of the MRE at Koko Massava is now expected next week and the Conceptualised Pit Optimisation completion remains broadly on target in December. While these delays are frustrating, on a positive note we have prepared for the commissioning of a Preliminary Economic Assessment to commence in January, pending the results of the MRE and Pit optimisation work.
