### Jobkeeper Payments Notification – Washington H. Soul Pattinson and Company Limited (WHSP)

**23 November 2021:** WHSP is a significant Australian investment house with a large diversified portfolio of investments across industries and asset classes.

WHSP has a resilient portfolio of investments which largely performed well throughout the Covid-19 affected period. The Parent Company, which is the investment holding company, did not require any government assistance and did not reduce its workforce.

The WHSP Consolidated Group includes a broader list of investee companies in which WHSP has a significant shareholding. The majority of the investee companies in the WHSP Consolidated Group also did not require any government assistance. However, as outlined in the attached notice, there were three entities which claimed assistance provided by the Federal Government's JobKeeper program, including:

- Aquatic Achievers, a private company providing learn-to-swim programs which was impacted by restrictions on attendance;
- New Hope, a publicly listed company which was impacted by a reduction in energy demand caused by Covid-19; and
- Tattersalls Hotel, a privately owned hospitality venue owned by a WHSP subsidiary which was impacted by restrictions on attendance.
