The Newcrest ShareMatch Plan provides eligible employees of Newcrest Group with an opportunity to sacrifice up to a specified amount of their salary per financial year to acquire fully paid ordinary shares in Newcrest. Newcrest will match an employee contribution up to a specified amount by granting one right for each share acquired under the salary-sacrifice arrangements. Each right is a right to receive a share at the end of a 3-year restriction period, subject to the employee remaining employed by Newcrest Group and satisfactory performance. The shares acquired under the Plan cannot be forfeited and will be released early if the employee ceases employment before the restriction period ends. Pro-rata vesting of rights may occur on cessation of employment in certain circumstances.
