

### Nature of Change

The Lesh Group has ceased to be an associate of any Other Requisitionists, and has no relevant agreement with any of them, as the issues set out in the Notices were resolved at the general meeting of Selfwealth held on 26 May 2022.

### Class and number of securities affected and affected votes

At the time of the Previous Notice, the Lesh Group had a relevant interest in 39,609,598 ordinary shares of Selfwealth. Pursuant to the change in association specified in Item 3 of this Form 605, the Lesh Group no longer has an interest in the 34,183,977 shares in Selfwealth owned by the Other Requisitionists.
