### NEARMAP SHAREHOLDERS TO VOTE ON THOMA BRAVO TRANSACTION

Nearmap Ltd (ASX:NEA) (**'Nearmap'**) refers to its announcement of 22 August 2022 that it had entered into a Scheme Implementation Deed with Atlas AU BidCo Pty Ltd (**'Thoma Bravo BidCo'**), a wholly-owned subsidiary of funds advised by Thoma Bravo L.P. (**'Thoma Bravo'**), for a proposed scheme of arrangement under which Thoma Bravo BidCo would acquire 100% of the shares on issue in Nearmap for \$2.10 cash per share (**'Scheme'**).

#### **Court has made orders convening the Scheme Meeting**

Earlier today, the Federal Court of Australia made orders directing Nearmap to convene a meeting of Nearmap shareholders to consider and vote on the Scheme (**'Scheme Meeting'**) and approving the dispatch of an explanatory statement providing information about the Scheme together with notice of Scheme Meeting (together, the **'Scheme Booklet'**).

#### **Scheme Meeting**

The Scheme Meeting is scheduled to take place at **2:00pm (Sydney time) on Friday, 25 November 2022** and will be held at Dexus Place, Level 15, 1 Farrer Place, Sydney and virtually via an online platform at [web.lumiagm.com/329936813](http://web.lumiagm.com/329936813).

The Scheme Meeting will be held as a hybrid meeting which can be attended virtually or in person.

All registered Nearmap shareholders at 7:00pm (Sydney) on Wednesday 23 November 2022 will be eligible to vote at the Scheme Meeting.

#### **Scheme Booklet to be despatched shortly**

Information relating to the Scheme including the notice convening the Scheme Meeting, information on how to participate in the Scheme Meeting, as well as an independent expert's report, will be included in the Scheme Booklet expected to be sent to Nearmap shareholders on or before 25 October 2022, following registration of the Scheme Booklet by the Australian Securities and Investments Commission (**'ASIC'**).

A further announcement attaching the Scheme Booklet will be made by Nearmap following registration of the Scheme Booklet by ASIC.
