## NEW ENERGY SOLAR (ASX: NEW)

U.S. ASSET SALE COMPLETION

New Energy Solar (ASX:NEW) advises that the conditions precedent for completion under the sale and purchase agreement (**MIPA**<sup>1</sup>) with MN8 Energy as described in the Extraordinary General Meeting Notice of Meeting released on 22 August 2022 have been satisfied and completion has occurred.

The U.S. dollar (**USD**) proceeds payable under the MIPA will be used to repay NEW's USD corporate debt facility and remaining proceeds, net of the Escrow Amount and amounts for the estimated future US tax liability resulting from the sale and other US liabilities, will be converted into Australian dollars (**AUD**). The AUD/USD exchange rate achieved, net of hedging costs implemented by NEW<sup>2</sup>, will be announced on or about 23 November 2022. At this time NEW will also provide an updated estimate of the previously estimated total return of capital range of \$0.95 - \$0.98 per share based on the exchange rate achieved and final transaction costs.
