Mogul Games Group Ltd (ASX: MGG) (**Mogul** or the **Company**) provides an update on the Company's operations as well as its Appendix 4C for the quarter ended 31 December 2022 (**Q4 2022**).

Buy and Build & Acquisition Update

During the previous quarter Mogul continued to assess opportunities and conduct diligence on profitable video gaming companies under its buy and build strategy. This included actively assessing the application of the esports platform.

The Company also continued to assess all inbound opportunities and potential acquisitions which would serve to increase shareholder value and will continue to keep the market updated in accordance with its continuous disclosure obligations.

Strong Balance Sheet

With ~A\$3.6m currently in cash reserves and no debt, the Company is in a strong position to accelerate its acquisition strategy.

Expenditure Summary

During Q4 2022, a total of ~\$A144,000 was spent on staffing costs and ~\$A302,000 on administration and corporate costs - related in part to the legal, financial and operational due diligence costs associated with the buy and build strategy.

Mogul notes that in Q4 2022, the Company paid ~\$A148,000 to directors of the Company in fees, salaries, and superannuation.
