## VOTING/PROXY FORM (AND ADMISSION CARD) FOR PUSHPAY HOLDINGS LIMITED NEW SCHEME MEETING

This form is for a special purpose special meeting of shareholders (the 'New Scheme Meeting') of Pushpay Holdings Limited ('Pushpay'), for shareholders to consider and vote on the revised scheme of arrangement under which Pegasus Bidco Limited proposes to acquire all of the Shares in Pushpay (the 'Scheme' and the resolution to be voted on being, the 'Scheme Resolution'). The terms and conditions of the Scheme are explained in the Supplementary Scheme Booklet dated 3 April 2023 to be read in conjunction with the Scheme Booklet dated 3 February 2023.

Capitalised terms used in this form and not otherwise defined have the meanings given to those terms in the Supplementary Scheme Booklet.

**Your vote is important and you are strongly encouraged to exercise your right to vote.** The Scheme Resolution will be put as a single resolution for the purposes of confirming the approvals of each interest class and a simple majority of the votes of all shareholders.

**Your vote in respect of the previous Scheme Meeting on 3 March 2023 does not count in respect of the revised Scheme. Therefore, to have your say on the revised Scheme you must vote again. The closing time for proxy appointments is 10:00 am on Wednesday, 26 April 2023 (NZT).**

The New Scheme Meeting will be held online by virtual webcast at [www.virtualmeeting.co.nz/pphscheme23](https://www.virtualmeeting.co.nz/pphscheme23) on **Thursday, 27 April 2023 commencing at 10:00 am (NZT)**. Pushpay will also hold a concurrent physical meeting at the offices of **Link Market Services, Level 30, PwC Tower, 15 Customs Street West, Auckland**. If you attend online, you will require your Holder Number for security purposes.

You can use this form to appoint a proxy and give your proxy voting instructions on the Scheme Resolution. You can also appoint your proxy to vote on the Scheme Resolution by going to [vote.linkmarketservices.com/PPH](https://vote.linkmarketservices.com/PPH) or by scanning the QR code above with your smartphone.

## IMPORTANT INFORMATION

### Entitlement to vote

The only persons entitled to vote at the New Scheme Meeting are registered shareholders at 10:00 am on 26 April 2023 (NZT).

### Appointment of proxy

Any shareholder entitled to attend and vote at the New Scheme Meeting can appoint a proxy to attend and vote. A proxy need not be a shareholder of Pushpay. Any corporation that is a shareholder of Pushpay may appoint a person as its representative to attend the New Scheme Meeting and vote on its behalf, in the same manner as that in which it could appoint a proxy.

If you appoint a proxy, you can either direct your proxy how to vote (by ticking the “For”, “Against” or Abstain” box) or let them decide on your behalf by ticking the “Discretion” box. If you do not tick a box for the Scheme Resolution, or the form is otherwise unclear, then your proxy will be treated as having discretion on how to vote. If you return this form without appointing a proxy, or your named proxy does not attend the New Scheme Meeting, the Chair of the meeting will be your proxy and will vote in accordance with your express direction. If you have not provided an express direction, the Chair of the New Scheme Meeting and any other Non-Conflicted Director appointed as proxy intend to vote undirected proxies in favour of the Scheme Resolution unless the Non-Conflicted Directors have changed their recommendation prior to the New Scheme Meeting, in which case the Chair and all other Non-Conflicted Directors of Pushpay will vote undirected proxies against the Scheme Resolution. For the appointment of a proxy to be valid, you must deliver, post or email your completed Voting/Proxy Form so it is received by Link Market Services Limited, or appoint a proxy online on the basis set out above, by no later than **10:00 am, Wednesday, 26 April 2023 (NZT)**.

### Voting of your holding

If you tick the ‘Discretion’ box for the Scheme Resolution, you are directing your proxy to decide how to vote on that resolution on your behalf. If you tick the ‘Abstain’ box for the resolution, you are directing your proxy not to vote on the Scheme Resolution. If a proxy does not vote on your behalf on the Scheme Resolution, your votes will not be counted when calculating the majority of that resolution.

### Appointing the Chair of the New Scheme Meeting or any other Non-Conflicted Director of Pushpay as your proxy

If you wish, you may appoint the Chair of the New Scheme Meeting or any other Non-Conflicted Director as your proxy. The Chair or other Non-Conflicted Director will vote according to your express direction or, if you have not provided an express direction, undirected proxies will be voted in favour of the Scheme Resolution (except as otherwise set out in this form).

### Changing or revoking your proxy instructions

You may, before the deadline for valid proxy appointments, change the identity of your proxy or your voting instructions by providing an updated form online, or via email, post or delivery, so it is received by Link Market Services Limited by no later than **10:00 am, Wednesday, 26 April 2023 (NZT)**. You may also revoke your proxy appointment by written notice to Link Market Services via email, post or delivery before that deadline. If you attend the New Scheme Meeting in person or online you may, but are not required to, revoke your earlier proxy. The last proxy appointment and voting instructions received by Link Market Services will prevail over any previous appointment or instructions.

### **Attending the meeting**

If you propose to attend the New Scheme Meeting in person please bring this form (with all pages intact) with you as the barcode on the front page is required for registration at the New Scheme Meeting. ### **Signing instructions for proxy forms**

#### *Individual*

Where the shareholding is one individual, the shareholder must sign this Voting/Proxy Form (or their duly authorised attorney).

#### *Joint Holding*

Where the holding is in more than one name, all of the joint shareholders (or their duly authorised attorney) must sign this Voting/Proxy Form.

#### *Power of Attorney*

If this Proxy Form has been signed under a power of attorney, a copy of the power of attorney under which it was signed (if not previously provided to Link Market Services Limited), and a signed certificate of non-revocation of the power of attorney must accompany this form.

#### *Corporate Shareholder*

In the case of a corporate shareholder, a duly authorised person or director must sign this Voting/Proxy Form. Persons who sign on behalf of a corporate shareholder must be acting with that corporate shareholder's express or implied authority, or execute under the common seal of the corporate shareholder (if it has one).
