Mogul Games Group Ltd (ASX: MGG) (**Mogul** or the **Company**) provides an update on the Company's operations as well as its Appendix 4C for the quarter ended 31 March 2023 (Q1 2023).

Acquisition Update

The Company continued to assess all inbound opportunities and potential acquisitions which would serve to increase shareholder value. As per the suspension announcement (ASX Announcement 29th March 2023), the Company expects to release an announcement in relation to a proposed re-compliance transaction under Listing Rule 11.1 in the coming weeks.

Strong Balance Sheet

With ~A\$2.839m currently in cash reserves and no debt, the Company is in a strong position to accelerate its acquisition strategy.

Expenditure Summary

During Q1 2023, a total of ~\$A161,000 was spent on staffing costs and ~\$A694,000 on administration and corporate costs - related in part to the legal, financial and operational due diligence costs associated with the acquisition strategy.

Mogul notes that in Q1 2023, the Company paid ~\$A106,953 to directors of the Company in fees, salaries, and superannuation.
