Charter Hall Social Infrastructure REIT (ASX: CQE) today announces the results of the June portfolio

CQE had 361 independent valuations completed for the period ending 30 June 2023, representing 100% of the portfolio1 by gross asset value.

The valuations resulted in a net decrease of \$10.0 million or 0.5% on prior book values. The average passing yield on these properties has increased by 12 basis points from 4.85% to 4.97%.

On 14 June 2023, CQE also declared the distribution for the quarter ending 30 June 2023 of 4.3 cents

The distribution reinvestment plan will be active for this period.

CQE will report its Financial Year 2023 Results on 11 August 2023.
