### Appendix 3Y - Change in Director's Interest Notice

The Appendix 3Y relates to a change of noticeable interests of one of the Company's Directors, Ms Tracey Fellows, being the disposal of 45,000 Class A Shares held in News Corporation, a related body corporate of REA Group Ltd, on 7 June 2023.

In preparing for its 30 June year end reporting process, the Company became aware that this disposal had not been previously disclosed in an Appendix 3Y. Given that the disposal did not relate directly to shares held in the Company, there was an inadvertent omission to notify the Company of the disposal in the usual manner.

The Company has taken steps to ensure the relevant Director (and all Directors) continue to be aware of ASX Listing Rule 3.19A and 3.19B and their obligations to provide the necessary information to the Company to enable it to meet its disclosure requirements. REA has reviewed the processes in place for the reporting of Director interests and considers that this was an isolated incident and that appropriate arrangements are in place to ensure timely notifications going forward for all Directors' interests.
