Interest is payable at 0.5% p.a. in the first year, after a grace period of 12 months. The facility expires on 20 May 2026. ○ In June 2020 SomnoMed Germany GmbH (Germany) entered into a EUR 0.5 million government-backed unsecured loan facility with Commerzbank. Interest is payable at 3% p.a. with a maturity of up to 6 years. ○ On 25 July 2022, SomnoMed Limited entered into a A\$16 million debt facility with Epsilon Direct Lending. The facility, which is supported by a first ranking general security interest, is for a term of 3 years, with no amortisation payments. The facility is currently fully drawn. Interest payable is calculated quarterly at BBSW, plus a 9% margin.
