Merger Effective Time

SYDNEY, Australia and Bellevue, Washington. – 10 August 2023 – <u>Limeade</u> (ASX: LME, or the Company), an immersive employee well-being company that creates healthy employee experiences, today confirms that the Articles of Merger have been filed with the Secretary of State of the State of Washington and the merger between Limeade and WebMD Health Corp (Merger) has become effective. Accordingly, WebMD Health Corp. has acquired all the shares of Limeade common stock in accordance with the terms of the Merger Agreement dated 8 June 2023.

We note that the suspension from trading of the Company's CDIs is still in effect. As the Merger is now effective, Limeade has applied to ASX that it be removed from the official list of the ASX with effect from the close of trading today.

We also advise in accordance with ASX Listing Rule 3.16.1 that each member of the Board of the Company (comprising the following persons) has now resigned as director, as required under Section 5.17 of the Merger Agreement: Elizabeth Bastoni, Henry Albrecht, Deven Billimoria, Steve Hamerslag, Mia Mends and Lisa Nelson
