## **SomnoMed Limited ACN 003 255 221 (ASX:SOM) – Successful completion of institutional placement and institutional component of Entitlement Offer**

SomnoMed Limited (**SomnoMed** or **Company**) is today pleased to announce the successful completion of the institutional placement ("**Placement**") and the institutional component ("**Institutional Entitlement Offer**") of its 1 for 3.82 accelerated non-renounceable entitlement offer of new fully paid ordinary shares (**New Shares**) in the Company (**Entitlement Offer**).

The Placement and Institutional Entitlement Offer closed on Friday, 1<sup>st</sup> September 2023.

Approximately 11.7 million New Shares will be issued to successful applicants under the Institutional Entitlement Offer at an issue price of \$0.60 per New Share (**Offer Price**), raising an aggregate of approximately A\$7.0 million. The Institutional Entitlement Offer had strong support from existing domestic and international institutional shareholders with a take-up rate of approximately 97%. The Placement also had strong support from both new and existing institutional shareholders with approximately 4.2 million New Shares to be issued, raising an aggregate of A\$2.5 million.

The shortfall of A\$251,309.40 (418,849 shares) from the Institutional Entitlement Offer has been placed to certain new and existing institutional investors. No shortfall shares were allocated to the sub-underwriter, TDM.

The use of proceeds of the Entitlement Offer was outlined in the Company's announcement on Thursday 31<sup>st</sup> August, and included working capital and a reduction in the balance of the Epsilon Direct Lending debt facility. As a result of the successful completion of the Placement and Institutional Entitlement Offer, SomnoMed's ordinary shares (**Shares**) will recommence normal trading on an ex-entitlement basis from the opening of the market Monday, 4 September 2023.

Shares issued pursuant to the Institutional Entitlement Offer and Placement will rank equally with existing Shares on issue with effect from their date of issue. New Shares subscribed for under the Institutional Entitlement Offer and Placement are expected to be settled on Thursday, 7 September 2023 and to be issued and commence trading on the ASX on Friday, 8 September 2023.

### **Retail Entitlement Offer**

The retail component of the Entitlement Offer (**Retail Entitlement Offer**) will approximately raise a further \$5.7 million.

The Retail Entitlement Offer is available to shareholders whose address is in Australia, New Zealand Hong Kong or Singapore as recorded with the Company's share registry as at 7.00pm (Sydney, Australia time) on Friday, Monday 4 September 2023 (**Record Date**) (**Eligible Retail Shareholders**).

Eligible Retail Shareholders are being invited to subscribe for 1 Share for every 3.82 Shares held on the Record Date at the Offer Price of \$0.60 per Share. The offer ratio and offer price for Shares under the Retail Entitlement Offer are the same as for the Institutional Entitlement Offer. Eligible Retail Shareholders who take up their entitlement in full under the Retail Entitlement Offer may elect to apply for that number of Additional New Shares in excess of their Entitlement which represents 100% of their Entitlement (**Additional New Shares**).

The Retail Entitlement Offer will open on Thursday, 7 September 2023 and close at 5.00pm (Sydney, Australia time) on Thursday, 21 September 2023 (unless extended or withdrawn).

Eligible Retail Shareholders wishing to participate in the Retail Entitlement Offer should carefully read the retail offer booklet and accompanying personalised entitlement and acceptance form, which are expected to be dispatched on Thursday, 7 September 2023. A copy of the retail offer booklet will be available on the ASX on Thursday, 7 September 2023.
