### Foreign Investment Review Board (FIRB) Approval

Estia Health Limited (**ASX: EHE**) (“**Estia Health**”, or the “**Group**”) refers to its announcement of 7 August 2023, 16 October 2023 and 10 November 2023, in relation to the proposed acquisition by Firebird BidCo Pty Ltd (an entity controlled by Bain Capital, LP) (**Bidder**) under which it is proposed that the Bidder will acquire 100% of the ordinary shares in Estia Health (**Shares**) for \$3.08 per Share in cash, by way of a court approved scheme of arrangement under Part 5.1 of the *Corporations Act 2001* (Cth) (**Scheme**).

Bain Capital, LP has today confirmed to Estia Health that the Bidder has received formal FIRB approval which will allow it to proceed with the transaction. Details of the Scheme timeline (which remains unchanged from our announcement of 10 November 2023) is summarised in Appendix A.
