# Scheme of Arrangement becomes legally effective

Estia Health Limited (**ASX: EHE**) (**Estia Health**) confirms that, further to its announcement on Tuesday, 5 December 2023, it has today lodged an office copy of the orders made by the Supreme Court of New South Wales (**Court**) approving the proposed scheme of arrangement (**Scheme**) under which all of the issued shares in Estia Health will be acquired by Firebird BidCo Pty Ltd, with the Australian Securities and Investments Commission (**ASIC**) pursuant to sub-section 411(10) of the *Corporations Act 2001* (Cth).

An office copy of the Court orders lodged with ASIC is attached at Annexure A to this announcement.

The Scheme is now legally effective and it is expected that quotation of Estia Health's ordinary shares on the ASX will be suspended from the close of trading today, Wednesday, 6 December 2023.

Estia Health shareholders (**Scheme Shareholders**) will receive \$3.08 cash per Estia Health share on the implementation date for the Scheme (being Friday, 15 December 2023) in respect of Estia Health shares held by the Scheme Shareholders at 7:00pm (Australian Eastern Daylight Time) on Tuesday, 12 December 2023.
