# Comms Group secures A\$2.4M contract with leading global SaaS provider

## Highlights:

- Comms Group has been awarded a major contract in partnership with Vodafone to provide IP based voice services to a leading global SaaS provider.
- Initial contract will deliver over A\$2.4M in revenue from upfront and ongoing service fees over a 3-year minimum term, with additional revenue to come from usage-based charges.
