LCL Resources Limited (**ASX: LCL**) (**LCL** or the **Company**) confirms the results of the general meeting of shareholders held this morning is as follows:

- Resolution 1 - not carried
- Resolution 2 - carried
- Resolution 3 - carried

The information required to be disclosed in accordance with ASX Listing Rule 3.13.2 and Section 251AA (2) of the Corporations Law is set out in the table attached.

Resolution 1 related to the proposed sale of the Company's Colombian assets under the Binding Option Agreement (**Option Agreement**) with Tiger Gold Corporation (**TGC**) first announced to ASX on 13 December 2024. With Resolution 1 not carried, TGC is unable to exercise its option granted under the Option Agreement and the Company will not receive the \$1 million upon the exercise of that option.



The Company will now discuss the outcome of the meeting with its stakeholders and report back to shareholders shortly.
