# Acquisition of Nilsen Switchboards Division

## Highlights:

- Strategic asset acquisition of the Switchboards Division of Nilsen (SA) Pty Ltd, including the N-Series product line and all associated intellectual property for \$4m cash.
- Approximately 66 employees are expected to transfer, strengthening Mayfield's skilled workforce and manufacturing capability.
- Expected to accelerate utilisation of the Royal Park manufacturing facility through increased operating scale.
- Acquisition includes \$3.9M of new Work-In-Hand and is expected to provide a revenue base of \$10-15M in FY27 following completion.
- Completion forecast of 31 July 2026 with progressive transfer of employees and assets through to 31 October 2026 to support smooth transition into Mayfield and allowing Nilsen to meet their contractual obligations.
- Expands Mayfield's switchboard offering across key Australian growth markets.
- Creates a stronger platform for organic growth through people, IP and customer relationships.
- Third strategic acquisition in twelve months, advancing Mayfield's Australian electrical infrastructure strategy.

Mayfield Group Holdings Limited (ASX: MYG) ("**MYG**", "**the Company**" or "**the Group**") is pleased to announce that it has entered into a binding Asset Sale Agreement to acquire the Switchboards Division of Nilsen (SA) Pty Ltd.

The acquisition includes the N-Series product platform and associated intellectual property, together with the expected transfer of employees, customer contracts, inventory, manufacturing assets, business records and operational capabilities associated with the division. The Nilsen brand and corporate business operations do not form part of the transaction.

## A Strategic Acquisition Focused on Workforce, Capability and Growth

This transaction is fundamentally about people, capability, capacity and growth.

The transaction includes the expected transfer of an experienced workforce of designers, estimators, project personnel and skilled tradespeople into the Mayfield Group at a time when specialist electrical manufacturing skills remain in high demand across Australia. Subject to completion, the transfer of these employees is expected to accelerate the utilisation of Mayfield's Royal Park manufacturing facility and support the Group's future growth initiatives.

In addition to the workforce, Mayfield will acquire the N-Series product platform, including associated intellectual property, engineering documentation, manufacturing know-how, technical records and product designs. The N-Series range is a proven switchboard platform with applications across commercial, industrial, infrastructure, defence, mining, utilities and data centre markets.

The transaction also includes \$3.9M of customer contracts and project opportunities expected to transfer or support a revenue base of \$10-15M and productive utilisation of the Royal Park facility following completion.

The acquisition complements Mayfield's existing switchboard capabilities through Mayfield Industries and BE Switchcraft and broadens the Group's ability to service a wider range of customer applications from a single manufacturing platform.

## Consideration and Financial Impact

The consideration payable for the acquisition is \$4.0 million subject to the usual price adjustments, and will be funded from existing cash reserves.

Completion remains subject to satisfaction or waiver of customary conditions precedent, including employee transfer thresholds and other completion conditions. There is no certainty that completion will occur until those conditions have been satisfied or waived.

## Strengthening the Royal Park Manufacturing Platform

The Royal Park facility was acquired by Mayfield in January 2026 to provide a scalable manufacturing platform to support the Group's future growth objectives.

Subject to completion, the Nilsen Switchboards Division is expected to include the transfer of employees, intellectual property and project opportunities that will support utilisation of this facility while creating additional opportunities for future revenue growth. The acquisition provides Mayfield with:

- Employees expected to transfer with electrical manufacturing experience;
- Customer contracts and project opportunities expected to transfer or support future work;
- The N-Series intellectual property and product platform;
- Additional engineering, estimating and project management capability;
- Manufacturing know-how and technical documentation; and
- Enhanced capacity to pursue larger and more diverse switchboard opportunities nationally.

## Management Commentary

**Andrew Rowe, Group Chief Executive Officer of MYG, said:**

*"This transaction is first and foremost about people and capability."*

*"We expect to welcome an experienced team of designers, estimators, project professionals and skilled tradespeople to Mayfield. Their expertise, together with the transfer of the N-Series intellectual property and product platform, is expected to strengthen our manufacturing capability and support utilisation of our Royal Park facility."*

*"Importantly, the acquisition also brings a pipeline of customer work and future opportunities that are expected to allow us to put this capability to work following completion."*

*"The N-Series platform complements our existing businesses and expands our ability to serve customers across commercial, industrial, infrastructure, defence, resources and data centre markets."*

*"Together, these capabilities further strengthen Mayfield's position in Australian electrical infrastructure manufacturing."*
