Upgrade to FY26 Guidance

IDT Australia Limited (ASX: IDT) (**IDT** or the **Company**) is pleased to announce an upgrade to its revenue and profit guidance for the financial year 2026 (FY26), reflecting favourable trading conditions and strong operational performance.

The Company is now expecting unaudited FY26 revenue from its three verticals to increase by 16.5% year-on-year (YoY) to \$16.8 million and for unaudited earnings before interest, tax, depreciation and amortisation (EBITDA) to improve significantly to -\$943K (vs. FY25: -\$6.3M).

The drivers behind the guidance upgrade include strong local and international demand momentum for IDT's world-class facilities and end-to-end drug manufacturing services, and cost savings running ahead of target. IDT will provide further details and outlook when it releases its full year results and audited accounts next month.

These awards acknowledge the expertise, innovation, and dedication of IDT's team in advancing RNA research, development, and manufacturing. They also reinforce IDT's growing leadership position in the rapidly expanding RNA therapeutics sector.
