June Quarterly Activities Report & Appendix 4C

Invex Therapeutics Ltd (Invex, ASX:IXC, or the Company) a biopharmaceutical company focused on the development and commercialisation of Exenatide for neurological conditions relating to raised intracranial pressure (ICP), today provides an operational and corporate update to accompany its Appendix 4C cash flow statement for the quarter ended 30 June 2026 (Q4 FY26).

Operational Update

Expanded Preclinical Research Program with Tessara Therapeutics

On 24 April 2026, the Company announced the commencement of an expanded preclinical research program with Tessara Therapeutics (Tessara), evaluating Exenatide and other GLP-1 receptor agonists, including novel combination regimens, in Tessara's clinically validated human induced pluripotent stem cell (iPSC)-derived three-dimensional Alzheimer's disease model, ADBrain™.

The expanded program builds directly on prior work reported, in which Exenatide demonstrated statistically significant improvements across multiple pathologically relevant biomarkers of Alzheimer's disease (AD). In particular, Exenatide demonstrated a potential neuroprotective effect against ferroptosis — an iron-dependent oxidative cell death pathway increasingly implicated in AD neurodegeneration — representing a mechanistically differentiated finding relative to current standard-of-care therapies.

The expanded study is designed to:

- **Benchmark Exenatide against a current GLP-1 agonist** enabling direct head-to-head comparisons of two clinically active GLP-1 receptor agonists;
- **Evaluate combination regimens** of Exenatide and a current GLP-1 agonist against approved AD symptomatic treatments, exploring additive or synergistic therapeutic effects over current standards of care; and
- **Evaluate novel combination regimens** of Exenatide and a current GLP-1 agonist with naturally-occurring factors that demonstrate synergistic improvements in AD phenotype.

Tolerability and efficacy assessments will utilise Tessara's validated assay suite measuring cytotoxicity, cell viability and ferroptosis, supplemented by assays aimed at characterising the mechanistic signature of each agent and combination.

Corporate Update

Financial Summary and Analysis

The Company closed the quarter with cash and cash equivalents of \$4,016,000 (Q3 FY26: \$4,517,000), with overall operating cash outflows for the quarter of \$501,000 (Q3 FY26: \$79,000).

Cash outflows from operating expenditure included:

- Payments for Research & Development expenditure for the quarter were \$379,000 (versus \$53,000 in Q3 FY26). R&D expenditure primarily relates the expansion of preclinical research program with Tessara.
- Administration and corporate costs of \$135,000 (versus \$67,000 in Q2 FY26). The costs primarily relates to ongoing compliance costs associated with an ASX listed company were incurred during the period.

Aggregate amounts paid to related parties of the Company and their associates included in the above costs were \$54k for the quarter.
