Of these shares, a total of 143,756 Performance Shares have vested to KMP, as noted above, and 30,584 Performance Shares have vested to a participant who is a former executive. The remaining 10,507 Performance Shares have been forfeited following testing and remain in the Wesfarmers employee share trust.
